The Aforesaid Original Certificates / documents should be submitted for verification to the college office. If the candidate is admitted, the College will retain the same. IN CASE OF ADMISSION ALREADY TAKEN ELSEWHERE:

If a candidate is unable to produce Original Documents: (1) <u>Statement of marks</u> of Qualifying examination (2) <u>School/College leaving Certificate</u> (3) <u>JEE(MAIN)-2014</u> <u>Scorecard</u> at the time of his or her admission on account of admission already secured to some other Institution, <u>he or she shall produce a certificate in ORIGINAL from the Head of the Institution</u> where he or she has already taken admission indicating that he or she has been admitted to a particular course in that Institution on a particular date and hence Original certificates have been retained in that Institution. The candidate shall produce the attested copies of these three certificates duly attested by the Head of the concerned institution. Seat will not be offered unless he/she produces these certificates as above.

The candidate who has submitted certificate from Head of the Institution as per above rule shall be required to pay the requisite fee at the time of admission itself.

The candidate shall sign an undertaking to the effect that he will submit the required original certificates to the college within <u>a period of not more than fourworkingdays</u> after the date of payment of fees.

If he or she fails to submit the necessary certificates within the allotted time limit given in the undertaking, his or her admission shall be treated as cancelled. Refund of fees shall not be applicable to such candidates and further they will also lose any claim to admission.

NOTE: Candidate should retain sufficient (at least 10 copies) attested photo copies of all the Original Certificates which they will submit during the time of admission to the college.
